Public Service Commission, West Bengal will conduct the **West Bengal Works Accountant Recruitment (Preli.) Examination, 2018 on Sunday, the 25th November, 2018 from 12:00 noon to 2:00 p.m. simultaneously at KOLKATA, BURDWAN, MEDINIPUR, BERHAMPORE, SILIGURI & DARJEELING centres.** The e-Admit Cards for the examination will be uploaded by the Commission in its website (<http://www.pscwbapplication.in>) on **17.11.2018** and candidates are advised to download their e-Admit Cards for the examination and take a printout thereof on and from **17.11.2018**. The admitted candidates shall have to produce the printout of their e-Admit Cards at the allotted venue for appearing at the specified examination. Candidates are advised to carry **two identical stamp size photographs** along with proof of identity such as Madhyamik or equivalent examination pass certificate/admit card which bears photograph of its rightful owner or Passport or PAN Card or UID No. Card (AADHAAR) or EPIC (Voter Identity Card) or Driving Licence and the printout of e-Admit Card at the venue of the Examination. **No paper Admit Card will be issued for this examination by the Commission and no such card will be sent to the candidates by post or will be available from the Commission's office.**

In case of any discrepancy in the e-Admit Card the same may be communicated to the Commission immediately to enable the Commission to take a decision in the matter.

Candidates are also advised to bring **Black Ball Point Pen** to the examination hall.

CANDIDATES ARE ADVISED NOT TO BRING ANY ITEM EXCEPT THOSE REQUIRED FOR THE PURPOSE OF EXAMINATION, e.g. ADMIT CARD, ID PROOF ETC.

CARRYING / USING ANY TYPE OF CALCULATORS, MOBILE PHONES, GADGETS OF COMMUNICATION IS COMPLETELY BANNED INSIDE THE PREMISES WHERE THE EXAMINATION IS BEING CONDUCTED.
